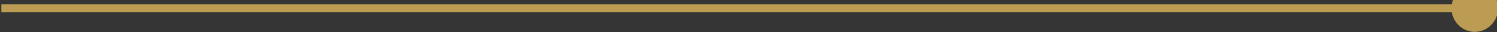

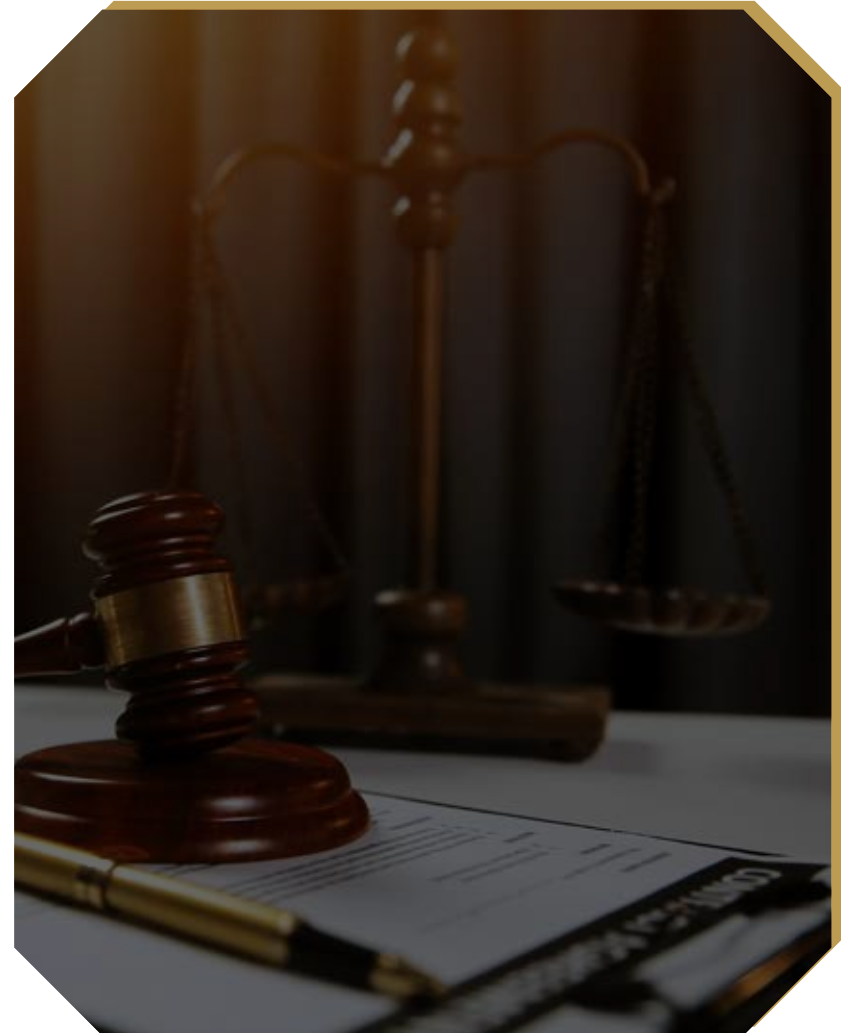

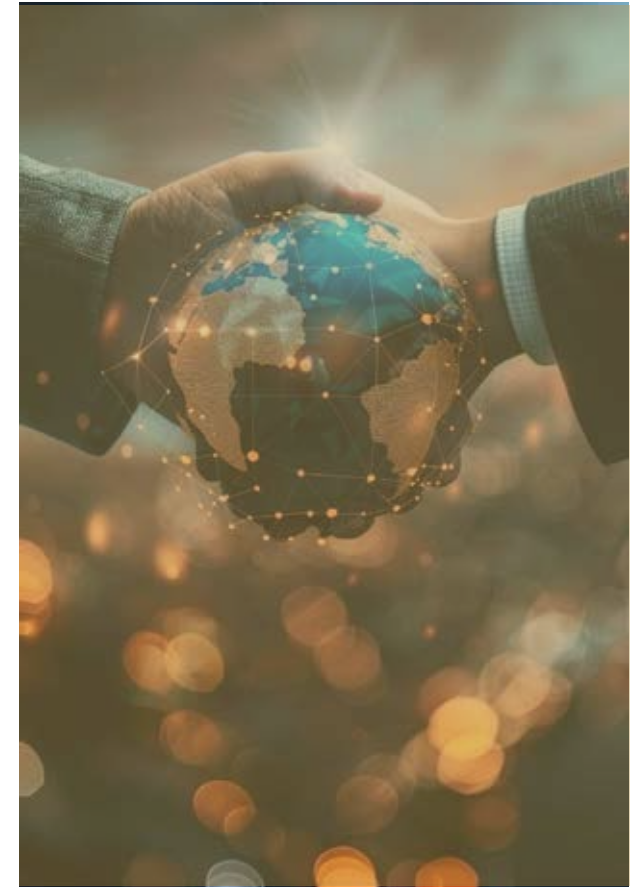
The Future Law Firm is distinguished by a wide international legal network, through partnerships with law firms outside Qatar and representation of important entities in international courts.
